But with the learning loss we want to keep sizes lower so that students have a lower teacher to student ratio in the electives and fine arts that will help promote mental health. We have also hired an additional Special Education Teacher to keep up with our IEP demands and ensure we are giving our students the best classroom structure to set them up for success. The district is going to be hiring a new counselor for our district to help with the needs of our students. The counselor will be responsible for the communication between house and school when students are missing work, they will help assess the needs of the student and arrange individualize plans for addressing the learning loss caused by COVID. This year the district has felt the heavy burden of what to do when the students are out sick, how to manage their missed work, ensure they are remotely connecting when possible, helping teachers get devices, work, etc to students. We have determined that a counselor that can help address the social and emotion needs of these children when dealing with the heavy burden of falling behind can also help deal with the learning loss work load. They can instruct tutoring to be set up in home or in district after school hours.
