SEAL OF CIVIC READINESS:

EXTRA-CURRICULAR PROGRAM and WORK-BASED EXPERIENCE STUDENT REVIEW and REFLECTION RUBRIC

Key Points:

- In order to earn the .5 points a student must earn the score of "Satisfactory" in every rubric category.
- If a student scores "Developing/Incomplete" in any rubric category, comments will be provided as to how the student can improve their score.
- After receiving their initial score and comments, a student can resubmit their Extra-Curricular Program/Work-Based Experience Student Review and Reflection one additional time.
- A student is always more than welcome to meet with the Seal of Civic Readiness Committee to discuss their score and comments prior to the resubmission of their work.
